FIRST AID:

If inhaled: If irritation occurs remove to fresh air and seek medical attention.

On skin contact: If irritation occurs wash immediately with plenty of water and soap.

On contact with eyes: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice.

On ingestion: Immediately rinse mouth and then drink plenty of water, do not induce vomiting, seek medical attention.

DIRECTIONS FOR USE: USE ONLY AS DIRECTED.

Space spray for use with an automatic aerosol dispenser such as the **ULTRAmatic units**.
If set to operate at every 15 minutes will last for approximately 720 hours (30 days).
Controls flying insects such as flies under continuous operation.
One unit controls premises up to 180 m³.
