### 4. FIRST AID MEASURES:

**Inhalation:** Remove patient from source of poisoning to a well-ventilated area and keep comfortable for breathing. If necessary, administer artificial respiration and oxygen.

**Skin contact**: Remove contaminated clothing and rinse contaminated body area thoroughly with plenty of soap and water. Do NOT rub skin.

**Eye contact:** Immediately rinse with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.

**Ingestion:** Get emergency medical help immediately. Do NOT induce vomiting. Do not apply direct mouth to mouth respiration. Never give anything by mouth to an unconscious person.

### **NOTE TO PHYSICIAN:**

Treat symptomatically and supportively. Administer Atropine sulphate, intravenously (1 to 4 mg) every 5 to 10 minutes until signs of atropinisation, (dry flushed skin and tachycardia); 2-PAM 50 mg/kg up to total dose of 1 to 2 g or two thirds of this dose of Protopam. Repeat oximes if necessary. Do NOT give morphine.

### Symptoms of human poisoning:

Headache, fatigue, faintness, giddiness, excessive sweating, nausea, abdominal pains, vomiting diarrhoea, tightness of the chest, anxiety, blurred vision, muscle twitching beginning in the eyelids and tongue, small pupils, respiratory distress, convulsions, coma in extreme cases.

### 5. FIRE FIGHTING MEASURES:

**Suitable Extinguishing Media:** Use dry chemical for small fires and water spray or foam for large fires.

**Unsuitable Extinguishing Media:** Carbon dioxide and high-volume water jet. Use a water jet only to cool heated containers.

**Specific Hazards:** Product decomposes in a fire to emit carbon monoxide, carbon dioxide, sulfur oxides and phosphorus oxides.

**Special Fire-fighting Procedures:** Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Fight fire from maximum distance. Remain upwind of fire. Avoid inhaling hazardous vapours and fumes from burning materials. Remove containers from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Do not scatter burning material. Water can be used to cool unaffected containers but must be contained for later disposal. Contain fire control agents for later disposal and do not allow to reach sewage or effluent systems.

**Personal Protective Equipment:** Wear NIOSH / MSHA approved self-contained breathing apparatus and full protective equipment to prevent contact with skin and eyes.

### 6. ACCIDENTAL RELEASE MEASURES:

**Personal precautions:** Avoid contact with eyes. Avoid breathing fume, vapours or spray. Ventilate area of spill or leak especially in contained areas. Use personal protective clothing. **Protective equipment:** As conditions warrant, wear a NIOSH approved self-contained breathing apparatus, or respirator, and appropriate personal protection (rubber boots, safety goggles, and heavy rubber gloves).

**Emergency procedures:** Alert firefighting personnel and evacuate unprotected personnel. **Environmental precautions:** Prevent spilled product from entering sewers, waterways or ground water.

**Methods and Materials for containment:** Contain spilled product by diking area with sand or earth.

**Methods and Materials for clean-up:** Soak up spillage with dry sand, shovel up carefully and place the material in a clean, dry and sealable container. Label container with the contents and dispose of as for toxic waste in accordance with local/national regulations. DO NOT burn. To decontaminate the spill area, tools and equipment, wash with water and suitable detergent. Collect wash water and add to the drums already collected. Do not flush spilled material or wash water into drains or waterways.

### 7. HANDLING AND STORAGE:

#### Handling:

**Precautions for safe handling:** Harmful if swallowed, in contact with skin or when inhaled. May be harmful if swallowed and enters airways. Avoid breathing fume, vapours or spray. Ensure adequate ventilation during handling and use. Do not handle broken packages without protective equipment. Immediately clean up spills that occur during handling. Keep containers closed when not in use. In the case of contact with the product referred to First Aid Measures – Section 4.

**General occupational hygiene:** Practice good hygiene when using this material. Avoid contact with eyes. Wash hands before eating, drinking, chewing gum, smoking, using the toilet or applying cosmetics. Worker should shower at the end of each workday. Launder all clothing before it is re-used.

### Storage:

**Conditions for safe storage:** Keep under lock and key and out of reach of unauthorised persons, children and animals. Store in its original, labelled container, tightly closed in a dry, cool and well-ventilated area. Do not store near heat, open flame, sources of ignition or hot surfaces. Not to be stored next to foodstuffs, feed and water supplies. Avoid cross contamination with other pesticides and fertilizers.

**Incompatible substances and mixtures:** Incompatible with strong acids, strong bases and strong oxidizing agents.

**Engineering controls:** It is essential to provide adequate ventilation. The measures appropriate for a particular worksite depend on how this material is used and on the extend of exposure. Local exhaust: Provide general or local exhaust ventilation systems to maintain airborne concentrations below RELs or other specified exposure limits. Local exhaust ventilation systems are preferred. ## **Personal Protective Equipment:**

### **ENVIRONMENTAL EFFECTS:** (for Temephos technical material)

**Plants:** In plants, oxidation to the sulfoxide and to a lesser extent, to the sulfone and the monoand di-orthophosphates. Further degradation proceeds very slowly.

Persistance and degradability: Temephos has low to moderate persistence in the environment.

**Bio-accumulative potential:** Temephos does not bio-accumulate in the environment. **Mobility in soil:** Temephos has a high affinity for soils. A half-life of 30 days has been estimated.

Other adverse effects: None known.

### 13. DISPOSAL CONSIDERATIONS:

**Waste:** Open burning or burning of this pesticide is prohibited. Waste resulting from the use of this pesticide cannot be reused or re-processed. Never pour untreated waste or surplus product into public sewers or where there is any danger of run-off or seepage into water systems. Do not contaminate rivers, dams or any other water source with the product or used containers. Comply with local regulations applying to waste disposal. The product may be taken to a registered waste disposal site.

**Container:** Emptied containers retain product residues and must be triple rinsed before disposal. Once all the pesticide formulation is decanted from the bottle, add one quarter of the container volume fresh water, screw the cap on and shake for thirty seconds. Pour the rinsate into the spray can. Repeat rinsing twice. Rinse the cap once with clean water. Puncture the triple rinsed container and dispose of via an approved collector or recycler (www.croplife.co.za). Do not bury,
