4. FIRST AID MEASURES:

- Skin contact:** Remove contaminated clothing and shoes. Wash skin thoroughly with plenty of non-abrasive soap and cold water or shower. Obtain medical attention if skin irritation or rash occurs.
- Eye contact:** Flush eyes with clean water for at least 15 - 20 minutes. Lift eyelids to facilitate irrigation. If present, remove contact lenses after 5 minutes and continue rinsing. If eye irritation persists, get medical advice.
- Ingestion:** Get medical help if swallowed. Do not give anything by mouth to an unconscious person. If the person is alert, rinse mouth thoroughly with water. Do NOT induce vomiting.
- Inhalation:** Keep patient calm and remove to fresh air. Seek medical attention if necessary.

Symptoms of poisoning: Dermal exposure may cause an allergic skin reaction, causing redness and discomfort. Headache, dizziness and hypersalivation can be experienced after long term exposure.

Note to physician: There is no known specific antidote. Treat supportively according to symptoms. The product contains a pyrethroid.

5. FIRE FIGHTING MEASURES:

Suitable extinguishing media: Use carbon dioxide or dry chemical for small fires and water spray for large fires.

Unsuitable extinguishing media: High volume water jet due to contamination risk. Product is a marine pollutant.

Specific hazards: The decomposed material emits toxic and corrosive fumes.

Special fire-fighting procedures: Personnel involved in a fire situation with this material should wear self-contained breathing apparatus as toxic and corrosive fumes may be given off. No unprotected person should be allowed in the vicinity. Remove spectators from the surrounding area. Fight fire from maximum distance and remain upwind from fire. Avoid inhaling hazardous vapours and fumes from burning material. Do not scatter the burning material. Water must be contained for later disposal.

Personal protective equipment: Wear NIOSH / MSHA approved self-contained breathing apparatus and full protective gear.

6. ACCIDENTAL RELEASE MEASURES:

Personal precautions: Use personal protective clothing. Avoid contact with the skin, eyes and clothing. Remove contaminated clothes, undergarments and shoes immediately after accidental contact. Ventilate area of spill or leak, especially in contained areas.

Protective equipment: Refer to Section 8 for personal protective equipment to be worn during containment and clean-up of a spill involving this product.

Emergency procedures: Alert firefighting personnel, evacuate unprotected personnel and animals.

Environmental precautions: Do not discharge into the subsoil or soil. Prevent spilled product from entering drains, sewers, waterways or groundwater.

Methods and material for containment:

Cover contained spill with an inert absorbent material such as sand, vermiculite or soil. Vacuum, scoop or sweep up and place into a clean, dry, sealable container. Label containers with the contents and dispose of according to local regulations. Do not place spilled material back in original container. Do not re-use spilled material. Do not flush spilled material or wash water into drains or waterways. Clean contaminated floors and objects thoroughly with water and detergents, observing

environmental regulations. Cleaning operations should be carried out only while wearing prescribed personal protective equipment.

7. HANDLING AND STORAGE:

Handling:

Precautions for safe handling:

Prevent contact with the skin and eyes. Wear rubber gloves when handling the product. Wash thoroughly with non-abrasive soap and water after accidental contact. Ensure adequate ventilation when handling the product. Keep containers closed when not in use. Immediately clean up spills that occur during handling.

General occupational hygiene:

Practice good hygiene when using this material. Wash hands before eating, drinking, chewing gum, smoking, using the toilet or applying cosmetics. Workers should shower at the end of each workday. Launder all clothing before it is re-used.

Note: During application and when cleaning protective clothing, contamination of all sources of drinking water, rivers, dams, other crops or grazing shall be prevented. The material is toxic to aquatic life.

Storage:

Conditions for safe storage:

Keep under lock and key and out of reach of unauthorized people, children and animals. Store away from food and foodstuffs. Avoid cross contamination with other pesticides and fertilizers.

The product must be stored in its original, labelled container, tightly closed in an isolated, dry, cool and well-ventilated area.
